Chamberlain Hrdlicka Reception Hall debuts at University of Houston Law Center

In recognition of Chamberlain Hrdlicka's continued support of the University of Houston Law Center, students, faculty, and visitors to the new John M. O'Quinn Law Building will enter and exit through the Chamberlain Hrdlicka Reception Hall.
