The firm was recently recognized by Visa as an "All Star" law firm for diversity and inclusion initiatives, and by Crain's New York Business as a finalist in its inaugural Excellence in Diversity and Inclusion Awards program.

Under Blair's leadership, the firm has also made significant financial commitments to organizations that pursue racial and social justice, including the Lawyers' Committee for Civil Rights Under Law.
